

# Terms of Use of Our Sites for Registered Users - v1.2

## **General**

These terms of use (together with the documents referred to in it) apply to Registered Users (defined below) and they tell you the terms on which you may register and make use of our series of destination websites, including this website, which are connected under the SeeTheWorld (STW) group (our sites).

Use of our sites includes accessing or browsing our sites as a Registered User. By making an enquiry or completing the "New User" checkout and/or successfully creating a username and password, you will become a registered user of our sites (a Registered User).

Please read these terms of use carefully before you register with our sites and start to use our sites as a Registered User, as these will apply to your use of our sites as Registered User. We recommend that you print a copy of these terms for future reference.

By registering and entering your details, you consent to receiving information from us about similar travelrelated products and services. You also agree to the terms and conditions of the Cookie Policy (see below) and the Privacy Policy (see below) that govern how your information will be processed.

By registering with our sites and using our sites as a Registered User, you agree to abide by the terms of use. If you do not agree with our terms of use please do not register with our sites or use our sites as a Registered User.

These terms of use include the following policies, which also apply to your use of our sites:

The references to 'us', 'we', 'our', 'ours', 'the Company' are references to Powder Blue Limited, who owns and operates our sites. We are registered in England and Wales under company registration number 3186762 and have our registered office at Bridgetts Farm Offices, Bridgetts Lane, Martyr Worthy, Winchester, Hampshire SO21 1AR, United Kingdom. Our main trading address is Number 3 Bridgetts Farm Offices, Bridgetts Lane, Martyr Worthy, Hampshire SO21 1AR, United Kingdom. Our VAT number is GB796 0384 92.

### **Changes to These Terms**

We may at any time and without prior notice change these terms of use and your continued use of our sites implies that you agree with those terms which apply at the time of your use. Please check this page from time to take notice of any changes we have made, as they are binding on you.

If you are a consumer, please note that these terms of use, their subject matter and their formation are governed by English law. You and we both agree that the courts of England and Wales will have non-exclusive jurisdiction. However, if you are a resident of Northern Ireland you may also bring proceedings in Northern Ireland, and if you are resident of Scotland, you may also bring proceedings in Scotland.

If you are a business, these terms of use, their subject matter and their formation (and any non-contractual disputes or claims) are governed by English law. We both agree to the exclusive jurisdiction of the courts of England and Wales.

### Registration

In order to book services through our sites and/or to receive emails suggestions, offers and recommendations, newsletters and details of new services, you will need to register as a Registered User of our sites.

### Eligibility to register

You must be at least 18 years old to register and we reserve the right to delete accounts of persons under 18 years of age.

#### Your Account and Password

If you choose, or you are provided with, a user identification code, password or any other piece of information as part of our security procedures, you must treat such information as confidential. You must not disclose it to any third party.

We have the right to disable any user identification code or password, whether chosen by you or allocated by us, at any time, if in our reasonable opinion you have failed to comply with any of the provisions of these terms of use.

If you know or suspect that anyone other than you knows your user identification code or password, you must promptly notify us at help@seetheworld.com.

#### **Number of Accounts**

Only one account per person is permitted and accounts cannot be transferred between users. We reserve the right to delete duplicate accounts.

#### **Closing an Account**

We reserve the right to delete your account where you are in breach of any of these terms of use and we are not obliged to return any content you have uploaded.

### Our Sites

Through our sites, we provide an online platform through which you may browse, learn about and book services directly with Service Providers (hereinafter defined). Service Providers means third parties who advertise and list their services via our sites (**Service Providers**). We act as a booking agent only in respect of bookings we make on your behalf with Service Providers. By booking services on our sites, you will be entering into a contractual relationship with Service Provider(s) and we act solely as an intermediary and agent.

You accept that we have not in any way selected, assembled or packaged travel products for you. We provide a search facility to enable your connection to those who do arrange travel products. Each travel product you choose is a separate booking, independent of other travel products booked at the same time. Your travel products are not a package and do not fall within the meaning of The Package Travel, Package Holidays and Package Tours Regulations 1992.

By proceeding to book services through our sites, you accept that you will be entering into a contract with the Service Provider on their standard terms and conditions.

Information on our sites is managed by us. Contributions and advertisements are also posted by third parties. We may update our sites from time to time and may change the content at any time.

Any details, prices, timetables or any other information relating to details of offers on our sites should only be considered indicative until such time as you have received written confirmation from the Service Provider operating the service or from us on behalf of the Service Provider.

Whilst we include hyperlinks and references to services and products from third parties for your convenience, we cannot be responsible for any materials on those sites. Any opinions, advice or advertisements on our sites are for your informational purposes only and do not constitute an endorsement of them.

The content on our sites is provided for general information only. It is not intended to amount to advice on which you should rely.

Our sites are made available free of charge.

#### **Strictly Necessary**

'Strictly Necessary' cookies are essential in order to enable you to move around our sites and use its features.

We use 'Strictly Necessary' cookies to ...

- Monitor return visits
- Identify you as being logged in to our sites
- Save you time and effort by remembering your preferences and settings such as modifying settings for feeds and alerts and so on

Accepting these cookies is a condition of using our sites, so if you prevent these cookies we cannot guarantee your security or predict how our sites will perform during your visit.

#### **Performance**

'Performance' cookies collect information about how visitors use our sites so we can improve the content we show to you. These cookies do not collect information that identifies a visitor. All information these cookies collect is aggregated and therefore anonymous. It is only used for internal usage to help provide a better user experience.

We use 'Performance' cookies to...

- · Recognize and count the number of visitors to our sites
- Help us to improve our sites by understanding how visitors move around our sites when they are using it
- Understand the best layouts and design concepts for our sites

Many of these performance cookies are set by a third party provider (third party cookies) as they are much smarter than us and there's no point recreating the wheel...However, we do not allow the third party to use the cookies for any purpose other than those listed above.

Using our sites indicates that you accept the use of 'Performance' cookies.

## **Functionality**

'Functionality' cookies allow our sites to recognise you when you return to our sites. This enables us to personalise our content for you, greet you by name and remember your preferences (for example, your choice of language or region). The information these cookies collect may be anonymised and they cannot track your browsing activity on other websites.

We use 'Functionality' cookies to...

- Store options you need to have the content on our sites presented properly
- Remember settings you have applied such as layout, text size, preferences and colours

· Watch video clips or comment on a blog

You can control whether or not these cookies are used, but preventing them may mean we cannot offer you some services, and will reduce the support we can offer you. It is also possible that preventing these cookie stops us remembering that you did not want a specific service.

#### **Targeting**

'Targeting' cookies record your visit to our sites, the pages you have visited and the links you have followed. ## **Privacy Policy**

We respect your privacy. This policy (together with the terms of use and the Cookie Policy) sets out the basis on which any personal data we collect from you, or that you provide to us, will be processed by us where you register with our sites and use our sites as a Registered User.

Please read the following carefully to understand our practices regarding your personal data and how we will treat it. By registering with our sites and using our sites as a Registered User, you consent to the collection, storage, processing and use of your personal data in accordance with this policy.

This policy applies to our sites and to news and/or weather alerts that you may subscribe to through any of our sites.

We will process the personal data that we collect from you or that you provide to us in accordance with the General Data Protection Regulation (GDPR) (EU) 2016/679 (the **Act**). For the purpose of the Act, the data controller is Powder Blue Limited of Bridgetts Farm Offices, Bridgetts Lane, Martyr Worthy, Winchester, Hampshire SO21 1AR, United Kingdom.

Personal data means information that relates to a living individual who can be identified from that information or from that information together with other information which is held by or likely to be held by us (**personal data**).

### **INFORMATION WE MAY COLLECT FROM YOU**

We may collect and process the following personal data about you:

- Information you give us. You may give us information about you:
  - by filling in enquiry forms on our sites or by corresponding with us by phone, e-mail or otherwise:
  - when you participate in discussion boards or other social media functions on our sites, enter a competition, promotion or survey and when you report a problem with our sites;
  - when you provide information to us for the purpose of registering with our sites;
  - when you provide information to us for the purpose of subscribing to and to news and/or weather alerts through any of our sites;
  - where you make a booking through our sites such as your address, date of birth, passport number and credit card details; and
  - when you provide information to us for the purpose of subscribing to our sites services, email notifications and/or newsletters.

The information you give us may include (but not be limited to) your name, address, e-mail address and phone number.

- **Information we collect about you.** With regard to each of your visits to our sites we may automatically collect the following information:
  - technical information, including the internet protocol (IP) address used to connect your computer to the internet, your login information, browser type and version, time zone setting, browser plug-in types and versions, operating system and platform. If you are using a mobile device, we might also collect data that identifies your mobile device, device-specific settings and characteristics and latitude/longitude details; and
  - information about your visit, including the full Uniform Resource Locators (URL) clickstream to, through and from our sites (including date and time); services you viewed or searched for; page response times, download errors, length of visits to certain pages, page interaction information (such as scrolling, clicks, and mouse-overs), and methods used to browse away from the page and any phone number used to contact us.
- Information we receive from other sources. We may receive information about you if you use any
  of the other websites we operate or the other services we provide. In this case we will have informed
  you when we collected that data that it may be shared internally and combined with data collected

on our sites. We are also working closely with third parties (including, for example, business partners, sub-contractors in technical, payment and delivery services, advertising networks, analytics providers, search information providers, credit reference agencies and Service Providers) and may receive information about you from them. We may also receive information about you when you use certain social media services.

#### **USES MADE OF THE INFORMATION**

We use information held about you in the following ways:

- Information you give to us. We will use this information:
  - to complete and administer your online reservation of services and forward your reservation details to the Service Provider. This may include information such as your name, your contact details, your passport details, your date of birth, your payment details, the names of guests traveling with you and any preferences you specified when making a booking;
  - o for administrative purposes, which may include for example, accounting and billing, auditing, credit or other payment card verification, anti-fraud screening (including the use of credit reference agency searches and payment card validation checks), immigration and customs control, safety, security, health, administrative and legal purposes;
  - to send you other material related to your reservations of services, such as how to contact us if you need assistance while you are away and information that we feel might be useful to you in planning your trip or making the most of your stay;
  - o to send you material related to upcoming reservations or a summary of previous reservations you made through our sites;
  - if you have not finalised a reservation online, we may email you a reminder to continue with your reservation;
  - to administer the account facility that we offer on our sites, allowing you to manage your bookings, take advantage of special offers, make future reservations more easily and manage your personal settings;
  - to invite you by email to write a guest review after your use of the services. This can help other travellers to choose the service that suits them best;
  - to provide you with the information, products and services that you request from us;
  - o to send you information about similar travel-related products and services;
  - to provide you with information about other services that are similar to those that you have already booked or enquired about through our sites;
  - to send booking confirmations and alerts, notifications or newsletters you have subscribed to, including to your mobile device; and
  - to contact you:
    - where you have requested that we do so or to respond to communications you have sent us;
    - where it is necessary to notify you about changes or updates to our service; and
    - where you have opted-in or as permitted by law, to send you marketing information regarding our services or those of selected third parties and to share your information with other companies providing travel related services for the purposes of marketing their products and services to you. You can opt-out of receiving such emails by clicking the unsubscribe link contained at the bottom of them.
- Information we collect about you. We will use this information:
  - to administer our sites and for internal operations, including troubleshooting, data analysis, testing, research, statistical and survey purposes;
  - to improve our sites to ensure that content is presented in the most effective manner for you and for your computer;
  - to allow you to participate in interactive features of our service, when you choose to do so;
  - as part of our efforts to keep our sites safe and secure;
  - o to measure or understand the effectiveness of advertising we serve to you and others, and, where you have given your consent, to deliver relevant advertising to you; and

- to show or, where you have given your consent, send suggestions, offers and recommendations to you and other users of our sites on our sites, in mobile apps or on third party websites including social media sites. These might be offers that you can book directly on our sites or third party offers or products we think you might find interesting.
- **Information we receive from other sources.** We may combine this information with information you give to us and information we collect about you. We may use this information and the combined information for the purposes set out above (depending on the types of information we receive).

#### Disclosure of Your Information

We may share your personal data with any member of our group, which means our subsidiaries, our ultimate holding company and its subsidiaries, as defined in section 1159 of the Companies Act 2006 in accordance with this policy and for the purposes set out above.

We may share your information with selected third parties to process your information on our behalf including:

- Business partners, suppliers, sub-contractors and Service Providers for the performance of any contract we enter into with them or you;
- Advertisers and advertising networks that require the data to select and serve relevant adverts to you and others. We do not disclose information about identifiable individuals to our advertisers, but we may provide them with aggregated information about our users (for example, we may inform them that 500 men aged under 30 have clicked on their advertisement on any given day). We may also use such aggregate information to help advertisers reach the kind of audience they want to target (for example, women in SW1). We may make use of the personal data we have collected from you to enable us to comply with our advertisers' wishes by displaying their advertisement to that target audience: and
- Analytics and search engine providers that assist us in the improvement and optimisation of our sites.

We may disclose your personal information to third parties:

- In the event that we sell or buy any business or assets, in which case we may disclose your personal data to the prospective seller or buyer of such business or assets;
- If Powder Blue Limited or substantially all of our assets are acquired by a third party, in which case personal data held by us about our customers will be one of the transferred assets;
- If we are under a duty to disclose or share your personal data in order to comply with any legal obligation, or in order to enforce or apply our terms of use and other agreements; and
